9. FINAL AND ARBITRATION CLAUSE. Any dispute should rise as for the relationships object of the present competition notice, it will be sent in judgement to an arbitration board made up of three members, of whom: a) one, with functions of president of the arbitration board, appointed by common agreement by F.I.T.P.'s President; b) one appointed by the contender; c) one appointed by common agreement by the subjects of whom at the two previous points a) and b) or, in case of failing agreement, by the President of the Court of Foggia.

For each exception not envisaged in the present regulation, the F.I.T.P., organizer of the Exhibition and this Competition, reserves the right to take final decisions.

This competition notice and the relative regulation of the Exhibition are drafted only in Italian. Any translations made by competitors and participants must be approved by F.I.T.P..
